Get Certified

Showcase to prospective employers that you are investing in yourself and your career advancement to help you stand out from your peers.

- **CIPM Certified Information Privacy Manager:** The CIPM stamp of approval is the first and only privacy certification for professionals who manage day-to-day operations.
- **CIPP/US Certified Information Privacy Professional/United States:** Focused on laws and regulations, the CIPP certification is the global standard for becoming an expert on privacy laws, regulations, and frameworks.
- **CIPP/E Certified Information Privacy Professional/Europe:** Focused on laws and regulations, the CIPP certification is the global standard for becoming an expert on privacy laws, regulations, and frameworks.
- CIPT Certified Information Privacy Technologist: For engineers and IT professionals, a CIPT certification is the industry benchmark for tech professionals looking to validate their knowledge of privacy requirements.









Consider adding software-specific certifications as well. OneTrust, for example, is a widely used privacy software platform, and the company offers <u>free</u> <u>online courses</u> and certifications in its software.

Peruse the education section on TRU's web site to source even more educational avenues to beef up your privacy resume. Or, <u>apply for a privacy</u> <u>scholarship through TRU</u> for help funding the cost of getting certified.

Visibility is credibility when seeking a job in a new industry: Attend as many industry events as you can – both in-person and virtually. You can find events like the <u>IAPP Global Privacy Summit</u> and Privacy.Security.Risk on the IAPP website. Consider joining your local <u>IAPP KnowledgeNet Chapter</u>

and become an active participant in live and/or online events. Be active on social media and network with data privacy peers and influencers. LinkedIn hosts many groups for privacy pros. Read the posts, ask smart questions, comment on interesting topics, and follow individuals who are taking the career path you would like to emulate. Consider standing out by becoming a content creator on LinkedIn: Only 1% of active LinkedIn users create content, and they get 9 billion impressions a week. As you gain knowledge and followers, consider authoring privacy-related articles and blog posts to make yourself known.

Stay Up-to-Date on Privacy News

Whether it's a data breach or new privacy regulation, something new is happening in the industry every day. Read the latest industry trends and happenings in the <u>TRU Knowledge Center</u>. Explore continuing education opportunities from the IAPP, attend IAPP KnowledgeNet Chapter meetings, and sign up for free privacy career webinars from TRU. Read <u>CPO</u> <u>Magazine</u> or otherindustry periodicals. Learn all you can about the industry to speak with confidence and authority to a prospective employer.

Raise Your Hand

Learn how data privacy programs operate in real life by volunteering to be a privacy champion within your current employer's business. Ask a privacy professional within your organization for opportunities to assist, learn, or liaise in your department. Volunteer to advocate for privacy policies and processes even if it isn't in your job description. See how privacy analysts manage data, what software they use, how they categorize materials, 4 and run reports. Gain a sense of how privacy projects are developed, implemented, and managed. If you have extra time in your weekly schedule, consider taking an entry-level or part-time privacy contract role to augment your existing knowledge.
